Report On CGM OFFICE CHALO Programme held on 15th March 2018

As per the call given by BSNL C&CWF Kolkata in their recently held CEC meeting, the Karnataka Circle BSNL NPWU observed the programme on 15th March 2018.

More than 1,000 comrades of BSNL NPWU came to CGM Office at Halasur from all the districts of Karnataka Circle. The Dharana started around 1100 hours.

The programme was to highlight the demands of Contract Workers with regard to the retrenchment of workers in the name of non availability of funds in BSNL, Non - payment of Minimum wages as per the orders of Central Government, to demand monthly payments before 7th of every month, payment of Bonus, issue of ID cards, proper recovery and remittance of EPF amount to the PF authorities, payment of Compensation amount to the family of a worker who demises while on duty at work spot, proper supply of required lines and wires materials for provision of connections, to revert back the recently formed tower company etc.,

The programme was inaugurated by Com.V.A.N. Namboodiri, President BSNL C&CWF CHQ. Com. Animesh Mitra, Secretary-General of BSNL C&CWF, Com.Gundanna C K Cir.Sec., BSNLEU & Cir. President BSNL NPWU KTK Circle; Com. Mahantesh, Gen.Secretary of BSNL NPWU Karnataka Circle, Com.Sudharshan Org.Sec.,BSNLEU CHQ, Com. M C Balakrishna, Cir.President,BSNLEU, Com. B P Narayana, Patron, BSNLEU Karnataka, Com.Balaji Rao Dist.President C I T U Mysuru, Com.Muddaiah, Cir.Sec., AIBDPA Karnataka Circle, Com. The programme concluded around 1700 hours with victorious slogans from the participants.
